

### **Approval Kit for the New Professionals' Forum 2023**

This document contains recommendations to craft a successful business case for new professionals who would like to attend the New Professionals' Forum on June 5th, 2023, at the Ottawa Art Gallery which is being hosted by the National Capital Region's Institute of Public Administration of Canada (IPAC-NCR). This template letter included in this kit is designed to seek management approval to attend the forum and to request funding via a learning plan to cover the costs associated with attending the event.

### Frequently Asked Questions (FAQ)

## 1. When and how should I talk to my manager about attending IPAC's New Professionals' Forum (NPF)?

The sooner, the better. However, before sending an official request to your manager to attend the event, have a discussion to provide them with more context on IPAC and the NPF. You can share takeaways from previous IPAC events if you are a returning participant and mention why you would like to participate in the forum. You can ask your manager to integrate this professional event into your learning plan. Most organizations have designated funding for employee training and professional development.

### 2. How can I integrate the NPF into my learning plan?

Integrating anything into your learning plan changes from organization to organization. Generally, following these steps should lead to successful integration into your learning plan.

- a) Introduce the conference to your manager and have a simple discussion about the value of the conference for your professional development.
- b) Send them your business case. You can use the template letter found below!
- c) If accepted, your manager will provide you with a learning form to fill out. Voilà!

### 3. How should I use the template?

Use the whole template or sections of the letter that work best for your purposes. If you use the whole template, try personalizing the competencies section to mention the skills, competencies, or knowledge you seek to gain by participating in the workshop (e.g., communication, organization, building your network, analysis, etc.) that are most relevant to your role and organization.

### 4. How much does it cost to attend the New Professional Forum?

This year, non-member tickets cost \$70 (incl. ticket processing fees) and member tickets cost \$59 (incl. ticket processing fees). A catered lunch will be provided.
